1	The total number of sections of Balvatika shall be restricted to 3(One each in

	be restricted to 22. The optimum number of the students shall be restricted to
	40 in each section. Any further increase of section shall require prior
	approval of the Board, subject to compliance with affiliation bye laws and

2	In the building safety certificate, 2 building blocks (Block A, Block B) with G+2 floors is mentioned, but the building comprises of 1 block with G+3 floors. The school should submit the revised building safety certificate within 3 months on SARAS portal.
3	The school should create separate reading area for staff in library and submit the compliance with videography within 3 months on SARAS portal.
4	The Lift to access upper floors is under construction. The school should complete the construction and submit the compliance with videography after installation within 3 months on SARAS portal.
5	Curtains are seen in the Composite Science lab which is fire hazard. The school should remove the curtains and upgrade the Composite Science lab in the light of SoPs issued by the Board and submit the compliance with videography within 3 months on SARAS portal.
6	Classroom benches are placed in the Maths lab. The school should upgrade the Maths lab as per SoPs issued by the Board and submit the compliance with videography within 3 months on SARAS portal.
7	General washroom for boys and girls are available on alternate floors. The school should construct general washrooms for both boys and girls on every floor and CwSN toilet, separately for boys and girls on every floor. There are no partitions in the boy's urinals. The school should create partitions and submit the compliance with videography within 3 months on SARAS portal.
8	The school should ensure training of teachers with CoE Guwahati and submit compliance within 3 months on SARAS portal.

subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.

- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
